

CHAPTER 17
ELECTION WARDS

SECTION:

1-17-1: Wards Established

1-17-1: **WARDS ESTABLISHED:** The city is hereby divided into four (4) wards, which shall be designated first ward, second ward, third ward and fourth ward, as follows:

FIRST WARD: The first ward shall include all that part of the city of Savanna lying northerly of a line commencing at the intersection of the centerline of Madison Street with the westerly city limits; thence easterly along the centerline of Madison Street, as projected easterly, to Diagonal Street; thence northeasterly along the centerline of Diagonal Street to the intersection of the centerline of Diagonal Street with the centerline of Cook Street; thence easterly along the centerline of Cook Street to the intersection of the centerline of Cook Street with the city limits.

SECOND WARD: The second ward shall include all that part of the city of Savanna lying south of the first ward and easterly of a line commencing at the intersection of the centerline of Madison Street with the westerly city limits; thence southerly along the westerly city limits to the centerline of the main line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company; thence easterly along the centerline of the main line of said railroad to the intersection of said centerline of said main line with the centerline of Park Street projected south; thence northerly along the centerline of Park Street to the intersection of the centerline of Park Street with the centerline of Chicago Avenue; thence westerly along the centerline of Chicago Avenue to the intersection of the centerline of Chicago Avenue with the centerline of Sixth Street; thence northerly along the centerline of Sixth Street, projected north, to the city limits.


THIRD WARD: The third ward shall include all that part of the city of Savanna lying east of the second ward and northerly of a line commencing at the intersection of the centerline of the main line of the Chicago,

Milwaukee, St. Paul and Pacific Railroad Company with the centerline of Park Street projected south; thence easterly along the centerline of the main line of the said railroad to the intersection of the centerline of said main line with the centerline of Viaduct Road; thence northerly along the centerline of Viaduct Road to the intersection of the centerline of Viaduct Road with the centerline of Chicago Avenue; thence easterly and northerly along the centerline of Chicago Avenue to the intersection of the centerline of Chicago Avenue with the centerline of Michigan Avenue; thence easterly along the centerline of Michigan Avenue, projected easterly, to the city limits.

FOURTH WARD: The fourth ward shall include all that part of the city of Savanna lying south of the second and third wards, being south of a line commencing with the intersection of the westerly city limits with the centerline of the main line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company; thence easterly along the centerline of the main line of said railroad to the intersection of the centerline of the main line of said railroad with the centerline of Viaduct Road; thence northerly along the centerline of Viaduct Road to the intersection of the centerline of Viaduct Road with the centerline of Chicago Avenue; thence easterly and northerly along the centerline of Chicago Avenue to the intersection of the centerline of Chicago Avenue with the centerline of Michigan Avenue; thence easterly along the centerline of Michigan Avenue, projected easterly, to the city limits.
